**SUBJECT: REVISED 2020 ACADEMIC CALENDAR FROM 29 JULY 2020**

## **1 PURPOSE OF THE MEMO**

The memo serves to inform the University community of the decisions of the Executive Committee of Senate meeting held on 29 July 2020 on matters related to the reorganization of the 2020 academic calendar. It should be noted that the calendar provides a broad framework for Schools to work within. For this reason, some Schools or even some academic programmes might finish the academic year earlier than the latest date indicated in the calendar.

## **2 SUMMARY OF THE MAIN ISSUES**

The main salient points from the revised academic calendar to be noted are the following:

- 2.1 On campus final year clinical and penultimate year clinical students will continue with the lectures from 29 July 2020, after the recent disruptions
- 2.2 On campus final year BSC students (including ECP 4 students) have continued with their academic programme from 29 July 2020
- 2.3 Remote multi-modal teaching and learning will be intensified from **10 August 2020**
- 2.4 Students who are still at home and are deemed to be vulnerable students will be brought to the campus or their off campus residences, once the DHET has approved the University's proposal in this regard. A process to quantify/verify/validate the exact number of vulnerable students has commenced in earnest, and the student leadership and the affected students will be kept informed as soon as feedback is received from the DHET in this regard. Notwithstanding the above, the University has made an undertaking that should any student be left behind during the ensuing teaching and learning, measures will be taken to ensure that those students complete the 2020 academic year.
- 2.5 Mid-year supplementary formative assessment for eligible students will be held on 26 – 30 October 2020, and the second Semester will commence on 2 November 2020.
- 2.6 Standard Examination will commence on 25 January 2021 and end on 19 February 2021, followed by supplementary/deferred examinations to be held during the week of 7 to 12 March 2021
- 2.7 The 2020 academic year will come to an end on 22 March 2021. Notwithstanding the above:
  - Final year students, depending on the pace at which they move with the implementation of the academic programme, including meeting the allotted clinical

requirements for their respective programmes may finish the academic year earlier than the last day of 22 March 2021.

- 2.8 Excluding five weeks of assessments (1 week of formative supplementary assessment and 4 weeks of summative assessment), the University has a total of **26 weeks of teaching and learning**.
